RATES

- Are per person and include a full English Breakfast and 15% VAT
- Valid until 31. December 2025
- Minimum 2 nights stay during public holidays and long weekends

GENERAL

- Guests may check-in any time from 14h00; rooms are to be vacated by 11h00
- Late check-outs may be arranged, on request and provided availability allows for this
- Airport transfers may be arranged at an extra cost
- Should guests check out before breakfast, a packed breakfast may be arranged
- Third person (12 years and above) @ R 1100 B&B – sharing with 2 full-paying guests
- Only guests booked to stay with us will be allowed to occupy the rooms
- No pets allowed.
- Service charge is discretionary

CHILDREN ... are most welcome

- Under the age of 12 years, they are accommodated free of charge when sharing with 2 adults.
- Children breakfast charge: 0-2 years = free | 3-12 years = R250
- Children occupying their own room pay the full rate

MEALS

- Breakfast, Lunch & Dinner are served either in the restaurant, veranda or wine cellar (Lunch & Dinner are served a-la-carte)

DEPOSIT & CONFIRMATION POLICY

- Provisional bookings will be held for 14 days
- 20% deposit required to confirm the reservation
- 10% of the full accommodation charge is non-refundable
- Balance is due in full 30 days prior to arrival date
- 100% non-refundable payment required on all bookings made 1 week prior to arrival
- Tour Operator / Agent reservations must be paid via EFT or Bank deposit 30 days prior to guests' arrival

CANCELLATION POLICY

- Cancelled 31 days or more prior to arrival - 10% of total booking value
- Cancelled 30 – 15 days prior to arrival - 50% of total booking value
- Cancelled 14 - 8 days prior to arrival - 80% of total booking value
- Cancelled 7 days prior to arrival - full payment retained
